ReSPECT Update



As the adoption of ReSPECT continues to increase around the country, so too does evidence of the increasing need for personalised care planning, and the need for individuals to plan ahead for their own future emergency care.

In July, we published a statement on ReSPECT's impact on reducing potentially avoidable emergency admissions from care homes, written in response to a recent report by the Improvement Analytics Unit and Health Foundation. Read here >

The Ticketing System has a search box which links to our frequently asked questions (FAQs) for Candidates, Course Centres, Instructors and for the LMS; it will guide you towards the appropriate answer to your enquiry.
